#### **Regulations**

- Federal laws set the minimum age, training steps, and evaluation process for operators.

- Employers must keep records showing that each operator is properly trained.

#### **Training**

- Training includes classroom or online lessons plus supervised hands-on practice.
- Operators must show they can use the equipment safely and follow workplace procedures.
- Training teaches safe driving habits designed to prevent accidents.

#### **Test**

- A qualified trainer gives a written or online test to check safety knowledge.
- A hands-on driving test makes sure the operator can handle the forklift correctly in real situations.
- Both tests must be passed to earn certification.

#### **Certification Cost**

Prices vary by provider, but online programs are usually more affordable than in-person classes.

- An operator has an accident or near miss.
- Unsafe driving is observed.

- New hazards appear in the workplace.

#### **Certification Renewal**

#### **Training Requirements**



Employers must regularly watch operator performance to decide when refresher training is needed.

#### Requirements

Pass a final performance evaluation to prove they can drive safely.



Do supervised hands-on practice with a qualified trainer

These steps apply to anyone who drives powered industrial trucks.

OSHA requires refresher training every three years.



Extra training is required after an accident or near miss.



Unsafe driving or bad habits also trigger retraining.
